We are pleased to announce that the Editorial Board has made the arrangement for publication of The Barishal University Journal of Business Studies, **Volume 8, Issue 1, June 2021**, a half-yearly publication of Barishal University under the Faculty of Business Studies. The authors are cordially requested to submit papers to the associate editor of the journal by **March 31, 2022** following the guidelines below:

1. The paper should focus on contemporary aspects of business and economics.
2. The paper should be based on original unpublished research work and should demonstrate the authors' own analyses and recommendations.
3. All submitted papers would go through blind peer review process before a final decision of acceptance/rejection for publication is taken.
4. Manuscripts:
Soft copies of the paper should be submitted along with one hard copy to the editor. The manuscript must be typed on one side of an A4 size paper, double spaced with margin: left, 1.5" and others, 1.0" and should not normally exceed 15 pages including reference list; font name: Times New Roman; font size: 12. The article should be in one column.

An abstract of maximum 150 words with keywords should be submitted. The cover page of the manuscript should contain: (a) A title of the manuscript, (b) Name (s) of the author(s) (c) Address of the author(s) including designation and institutional affiliation, and (d) Phone number and E-mail address.

5. References: The details of all references should follow Harvard Referencing method mentioned as follows:

Order of listing: The List of References should be ordered alphabetically by primary author's surnames.

* Multiple authors: Use the sequence of authors surnames exactly as given in the publication. The primary author, ie. Major contributor, is listed first by the publisher.

* Same author: i) different years: list the author's references chronologically, starting with the earliest date
ii) Same year: use an alphabetical suffix (eg. 1983a, 1983b).

6. All papers will be published in English and manuscripts must be submitted accordingly. Articles are accepted for publication on the understanding that they are subject to editorial revision. Manuscripts requiring extensive editorial work will be returned to the author for modification.

7. Either British or American style of spelling can be followed but mixture of these two will not be accepted.

8. Footnotes should be avoided. Essential notes should be numbered consecutively in the text and grouped together at the end as annexure.

9. Initial screening of the papers for publication is made by the editorial board followed by final assessment by the reviewers.

10. Faculty of Business Studies, University of Barishal, will not assume any responsibility for loss or damage of manuscript sent through mail.

11. The University Journal committee will not take any responsibility for opinions expressed in the articles/papers published in the Journal.

12. All copies of the articles should be submitted to Mohammad Rakibul Islam, Associate Editor, Barishal University Journal of Business Studies. You send only the soft copy of the article due to pandemic situations in the following e-mail address: mrislam@bu.ac.bd

13. The copyright of the paper will be reserved by BUJBS once the article is accepted for publication.

14. A copy of the published journal will be sent to the author free of charge. The author will have to indicate the numbers of reprints beforehand.

15. Similarities of the article will be checked by the software. More than 25 percent (except references) will not be allowed.
